

EXPRESS CONSENT FOR THE PROCESSING OF YOUR DATA BY TRICOSOL TRICICLOS, S.L



In our business, we are concerned about the protection of your personal given to us so that we can give our service in the best conditions and in your best interest.

For this, we require that you give us your consent for the treatment of the given personal data, however, not without knowing the purpose of it:

Your consent is fundamental and one of the principles of data protection according to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 relating protection of natural persons with regard to the treatment of personal data and the free circulation of these data and repealing the Directive 95/46 / EC (General Data Protection Regulation):

Your consent is an essential requirement for us to treat your data.

And we need to process your data to offer our service in optimal conditions.

By treatment we mean, the management and use of your personal information, consultation and protection. In order to obtain the data, there must be a free communication on the party who gives his data - of the interested party - for which he accepts our treatment.

However, how to give your consent without knowing what is the specific purpose of it, what are the conditions, or what are your rights regarding the transfer of these data? We inform you so that you know briefly before giving your consent

Is this a free consent?

YOU DO KNOW that we need your data to manage the service you hire. Without it , we could not communicate with you, send relevant information or manage our rights and obligations with you.

Your consent is given in a framework of freedom. You yield your data, because you know that we will treat them according to all security conditions so that there is no interference for third parties, we will not give your data to third parties and we will protect them with the utmost diligence and complying with all the legal requirements. They will be used exclusively justified in relation to the service they hire and for the time necessary for the service to be offered. You know that this treatment will be based on solely and necessary the data for your identification and contact, within the provision of our service. Your data will not be used for any other purpose, such as the preparation of databases or for marketing purposes.

Who is responsible for my data being transferred exclusively for the service contracted and keep it taking all security measures?

You will be able to exercise your rights before TRICOSOL TRICICLOS, S.L.

You can exercise your data processing rights against the person in charge at our physical location in Calle vendeja nº 6, Málaga (Spain) or via email info@biketoursmalaga.com You can access our files to know that we really only have the necessary data.

If you do not agree to it, you can cancel the data, which are deleted, by exercising the right of cancellation. Or rectify them if you think they are inaccurate, incomplete, erroneous or excessive.

If you believe that they have been used without your consent or for a different purpose for which you gave your consent you may exercise your right to object.

If you believe that these data should be limited in your treatment you may request the suspension of them. You can also request the copy and processing by a new responsible person by exercising your portability right, and / or request the deletion of the data if you consider that these were assigned to third parties.

The person in charge will offer you the exercise of these rights and show the procedure to exercise it.

How are we going to process your data?

Your data will be processed in the day-to-day management of the company with access to a file that includes your data. These are organized systematically on digital bases. They have backup in external devices, all of them located inside the headquarters located with special precaution to avoid unauthorized access. They will not be transferred to third parties and will be used only and when necessary with the sole purpose of managing the service or contacting you without invasive purposes in your privacy
